4. Purpose and legal basis for the processing of data

Data entered by you is collected to process your registration to our events. Your data is processed pursuant to Article 6 (1) b) GDPR. Please note that you may be filmed or photographed during the event. By signing up for our events, you give your consent that a picture and/or your appearance in a video may be used for publication (print, online, social networks, etc.).

5. Recipients or categories of recipients of personal data

Your personal data is transmitted to the following service provider: [Constant Contact](#).



We will share your data – if applicable – with the respective event partner or customer that we organize the event for. Information such as your name and company will be used for name tags and participant lists available during the event to facilitate exchanges between the individual participants.

6. Transfer of personal data to a third country

We transmit your personal data to a third country (USA) or an international organization.

The provisioning of your data is carried out by means of an online web application. Confidentiality, integrity (inviolability), authenticity (genuineness) and availability of personal data can therefore not be guaranteed.

7. Duration of storage

Your data will be stored until the event is done. Beyond that, legal retention periods may also require your data to be stored after the event.

Your data is stored after the event so that we can send you additional information and invitations for other events if you have given your consent to such. You may revoke your consent at any time.

8. Rights of the data subject

You have the following rights according to the EU General Data Protection Regulation:

If your personal data is processed, you have the right to obtain information regarding the storage of your personal data (Article 15 GDPR).

If incorrect personal data is processed, you have the right to the correction of such (Article 16 GDPR).

If legal requirements are given, you have the right to request the deletion or limitation of your data, and you have the right to object to any particular processing (Articles 17, 18 and 21 GDPR).

In the event of an objection, we will no longer be able to invite you to participate in our events, and we will subsequently remove your data from our mailing list.

Since data processing is based on a contract, and since data processing is carried out via automated processes, you have a right to data portability where applicable (Article 20 GDPR).

Should you exercise your above-mentioned rights, GACC Midwest will review whether statutory requirements are met.
